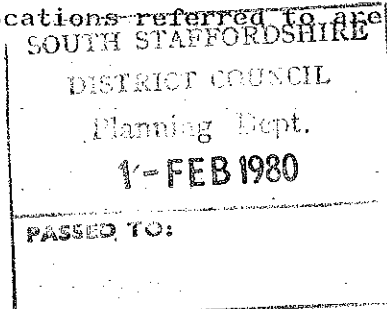


SOUTH STAFFORDSHIRE DISTRICT COUNCIL

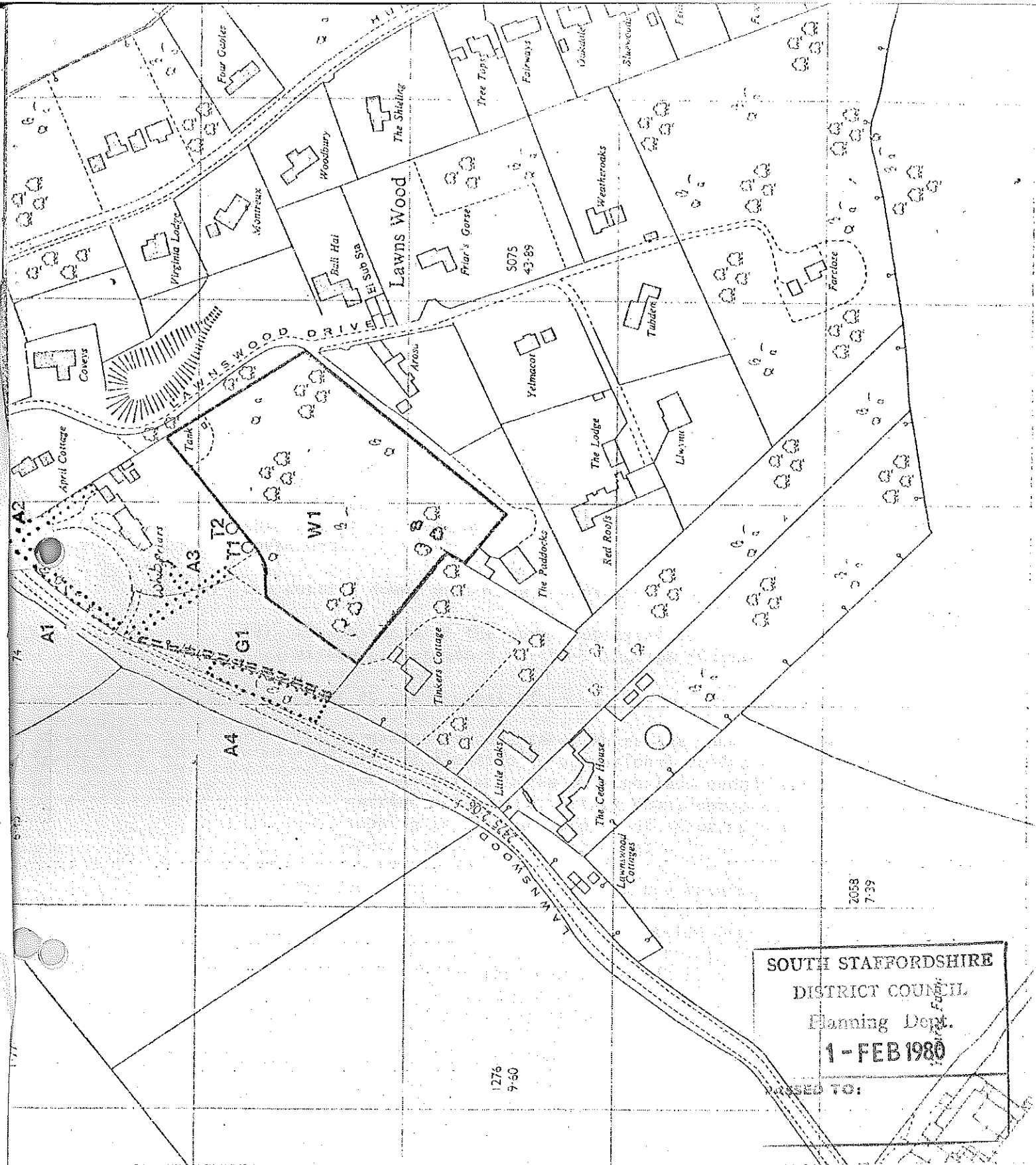
